

Thus, training your pitching skills, where you have usually only a very limited time to present yourself, your faculty or even an entire institution, are clearly valuable. Such networking events provide an excellent occasion to liaise and develop partnerships, to become more visible, to get involved and to be taken on board in research consortia.

Participants should come prepared to present their institution (research team/faculty/institute/SME) in up to a maximum of 2 minutes (preferably without the aid of a PowerPoint). While providing the presentation, please have in mind the following concept: you are at a networking reception or a brokerage event. You seek to collaborate with another partner(s) within a framework of a given call for applications of your choice. Remember - you have only 2 minutes to deliver your key message! Do your best to show to a potential counterpart that you are a solid partner for cooperation. Try to focus on relevant information and facts highlighting your potential for a research cooperation and mention what makes your institution attractive with regard to a particular call or project.



9:45 – 10:30 How to mobilize international cooperation via HE?


The second part will give an outlook on HE actions that enable researchers and their host institutions to either set up or engage in various international and interdisciplinary research networks.


9:00 – 09:30 Comitology and WP preparation – where to lobby?


